



Crow FM Cash Splash 2026 - Customer Competition Terms & Conditions

1. Promoter

The promoter of the Crow FM Cash Splash 2026 competition is Crow FM 90.7 ("Promoter").

2. Competition Period

The Crow FM Cash Splash 2026 competition commences at 12:00am on the 1st September 2026 and closes at 11:59pm on the 30th of November 2026 ("Competition Period").

3. Eligibility

Entry is open to Australian residents aged 18 years or over at the time of entry.

Employees, volunteers, committee members of Crow FM 90.7, participating Cash Splash businesses and their immediate families may be excluded from entering at the discretion of the Promoter.

4. How to Enter

To enter the Crow FM Cash Splash 2026 competition, customers must make a purchase of \$20 or more in a single transaction at a participating Cash Splash business during the Competition Period.

Eligible customers will receive one (1) entry into the Cash Splash draw for each qualifying transaction of \$20 or more.

Customers may receive multiple entries throughout the Competition Period by completing multiple qualifying transactions.

Entrants must complete the official Cash Splash entry form and provide all required details to be eligible.

5. Entry Requirements

Entries must be completed accurately and include all required information.

Entrants must retain their receipt as proof of purchase for each qualifying entry. The receipt must clearly show the participating Cash Splash business, transaction date and a purchase amount of \$20 or more.

The Promoter reserves the right to request proof of purchase and valid photo identification from the winner to verify eligibility before awarding the prize.

If an entrant is unable to provide satisfactory proof of purchase and identification when requested, the Promoter reserves the right to deem the entry invalid and select an alternative winner.

Incomplete, illegible, inaccurate or unverifiable entries may be deemed invalid at the discretion of the Promoter.

The Promoter accepts no responsibility for entries that are lost, late, damaged, incorrectly submitted or unable to be processed.

6. Prize

The winner will receive a cash prize of \$5,000.

The prize is not transferable and cannot be exchanged for any other goods, services or prizes.

Before the prize is awarded, the winner must provide valid photo identification and proof of the qualifying purchase receipt to confirm their eligibility.

The Promoter reserves the right to verify the winner's identity and eligibility before awarding the prize.

7. Winner Selection and Announcement

The winner will be selected via a random draw from all valid entries received during the Competition Period.

The winner will be announced live on Crow FM on the 12th of December 2026.

The winner will also be contacted using the details provided on their entry form.

8. Unclaimed Prize

If the winner cannot be contacted, is found to be ineligible, is unable to provide required proof of purchase and identification, or does not claim the prize within a reasonable timeframe as determined by the Promoter, the Promoter reserves the right to conduct a redraw and select an alternative winner.

9. Privacy

By entering the competition, entrants consent to Crow FM 90.7 collecting and using their personal information for the purpose of administering the competition, contacting entrants and conducting promotional activities associated with Cash Splash.

Personal information will be managed in accordance with applicable privacy laws.

10. Publicity

By accepting the prize, the winner agrees that Crow FM 90.7 may announce their name, suburb and/or photograph for promotional purposes, including on-air, online and through social media channels.
